The District would have to abide by the 0 percent cap on the tax levy increase, which means the same amount of taxes would have to be levied as in the current year or less. Elimination of all non-contingent items including capital outlay expense would be necessary to reduce the tax levy to the 2019-20 level as required by the current contingent budget rules. In developing a contingent budget, all programs besides those required to meet educational needs would be reviewed by the Board of Education.
