Here we are in the midst of Fall with winter quickly approaching. The last eight months have been the oddest of my career and I assume yours too. I don't think there are many people who ever thought we would be in a pandemic that seems all too often like a movie script. With that said, I am extremely proud of our District, the staff, and the students. The first quarter of the academic year has gone better than I personally expected and hope we continue on this trajectory of improvement for our students' sake. The majority of this newsletter is focused on updates to our current plans and the procedures we have had to reimagine due to the current regulations. I will highlight some of those in this opening letter, but please turn the pages to read the articles and other important messages from the District.

Hybrid Model: Our goals during this time continue to be to get as many students as possible into the building on an everyday basis for a full day with a focus on the students who struggle the most with virtual learning. As we are currently at full capacity in most areas based on the regulations, it appears we will need to stay in this hybrid model until social distancing regulations for buses and classrooms are released or reduced, whenever that may be. I encourage you as a parent to be as involved as you can with your student's virtual learning and with your student's teacher because there will be no free passes this year. Students will need to earn their way to the next grade level or class which is a good segue to parent conferences.

Parent Conferences are being reimagined for this year and will not be in person, but we know communication between parent and teacher is more important than ever. Teachers are being expected to contact all students with an average below 70 or are not performing well in their class if they don't use number grades. Teachers will be setting up times where they will either meet virtually or call parents. Most conferences will happen on November 23 & 24, but some teachers will begin contacting parents on November 9. Report Cards will be sent home with K-5 students and mailed to 6-12 students on or about November 19 (more details inside).

Winter is Coming: Snow days and delays are just around the corner, but due to our new schedule we are making adjustments to the procedure and have a plan to use virtual learning days if we use more than five snow days this year. Please see the page dedicated to this in the newsletter and put it on your refrigerator for future reference.

THANK YOU: Lastly, I want to thank each of you for your flexibility, efforts to get your children to school, positive attitudes, hard work, and support of the District so far this year. I hope, even though this year is frustrating for all of us, we continue to work together and support each other for the benefit of the students of the LaFargeville Central School District. It seems this year there are no answers or perfect solutions and every decision has a downside, but we continue to make decisions that are the safest or least problematic for the whole of our District and Community.







Drop-Off / Pick Up Procedures

Classes begin at 8:15 a.m. for grades K-5 and 10:15 am for grades 6-12. Please drop off students no earlier than 8:00 am for grades K-5 and 10:00 am for grades 6-12.

Buses only will be allowed in the circle by the office from 7:50 to 8:15 a.m., 9:50 to 10:15 am, 12:55 pm to 1:10 pm and 2:55 to 3:10 p.m. Please do not drop off or pick up your children there during these times.

Parent pickup/drop off during these times will be at the assigned door for your student's grade level. Your children will be supervised by a staff member when you drop them off and delivered to your car as you pick them up. We ask you not to leave your vehicle unattended, as the students will be brought safely to your car.

If you walk your child to school please walk them to the assigned door for their grade level.

If you are picking up your children for an appointment or due to illness between 8:20 a.m. and 2:45 p.m.; please use the bus circle doors entering the main office to sign your child out.

Emergency Drills

As you may or may not be aware, the LaFargeville Central School Safety Committee, consisting of faculty, staff, and community members, meets on a regular basis to review the district's emergency plans and procedures and to implement/review the state-mandated drills (bus, fire, lockdown, and emergency go home early) that are conducted throughout the year. Attendance Matters in Elementary School

Five Facts about School Attendance

- 1. Absenteeism in the first month of school can predict poor attendance throughout the school year. Half the students who miss 2-4 days in September and October go on to miss nearly a month of school.
- 2. Absenteeism and its ill effects start early. One in 10 kindergarten and first grade students are chronically absent. Poor attendance can influence whether children read proficiently by the end of third grade or are held back.
- 3. By 6th grade, chronic absence becomes a leading indicator that a student will drop out of high school.
- 4. Research shows that missing 10 percent of the school, or about 18 days, negatively affects a student's academic performance. That's just two days a month and that's known as chronic absence.
- 5. The academic impact of missing that much school is the same whether the absences are excused or unexcused.

Academic Information

Students in grades 3 through 6 will receive instruction designed for them to attain the NYS learning standards in:

ELA - English Language Arts, which includes reading, writing, listening, and speaking

Social Studies, including Geography and US History

Math, Science, and Technology

Arts, including Visual Arts, Music and Theatre

Career Development and Occupational Studies

Health and Physical Education

Students in grades 7 and 8 will receive instruction to enable them to achieve the following learning standards:

ELA – 2 units of study

Social Studies – 2 units of study

Math - 2 units of study

Science – 2 units of study

Foreign Language (Spanish or French) – 1 unit of study

Technology – 1 unit of study (partially embedded in core courses)

Home and Career Skills - 3/4 unit of study

Health Education – ½ unit of study

Physical Education – 1 unit of study

Visual Arts – ½ unit of study and 1/2 unit in Music

Library and Information Skills – Equivalent to 1 period per week (embedded in all courses)

Graduation Requirements

Students in grades 9-12 must complete the state mandated courses listed below to graduate from LaFargeville Central School with a Local/Regents Diploma.

Requirements:

English – 4 credits

Social Studies - 4 credits

Math – 3 credits (one must be a Regents math)

Science – 3 credits (one must be a Regents science)

Physical Education – 2 credits

Foreign Language – 1 credit

Health - 1/2 credit

Art/Music Requirement – 1 credit

Electives - 3 1/2 credits

22 total credits are required in addition to passing the following regents examinations:

Global History & Geography

US History & Government

Comprehensive English

One Math Regents: Algebra, Geometry, or Algebra 2

One Science Regents: Living Environment, Earth Science, Chemistry or Physics

Parents' Bill of Rights for Data Privacy and Security


The LaFargeville Central School District seeks to use current technology, including electronic storage, retrieval, and analysis of information about students' education experience in the district, to enhance the opportunities for learning and to increase the efficiency of our district and school operations.

The LaFargeville Central School District seeks to insure that parents have information about how the District stores, retrieves, and uses information about students, and to meet all legal requirements for maintaining the privacy and security of protected student data and protected principal and teacher data, including Section 2-d of the New York State Education Law.

Bus Transportation Student Home Drop Off:

Students Pre-K through 4 must have an adult or an older sibling at home to be dropped off. The adult in the house must be seen, not presumed to be there. If no one is there the children will be returned to school and the parent will be called to pick up the child. If in 5th grade or above the student can be dropped off without an adult seen.

Back Pack Program

ABRIDGED CODE OF CONDUCT

I. LCS STUDENTS ARE EXPECTED TO:

- * Know and follow the rules.
- * Be honest and responsible for your actions.
- * Talk to an adult when you or someone you know needs help.
- * Clean up after yourself and try to make the school/community a better place.
- * Be polite, respectful, and do your best.
- * Treat everyone with RESPECT!

II. STUDENT DRESS CODE:

Our community takes pride in the appearance of our students. Clothes can reflect the quality of the school, conduct, and schoolwork. Students are expected to dress in a manner that is appropriate for the setting. The following are items deemed inappropriate and unacceptable on school property, school buses, and at school functions:

- 1) Revealing, see-through or tight clothing, including but not limited to clothing that leave visible: Underwear, Bare tops, Bare midriffs and/or sides High thighs;
- 2) Clothing, jewelry, body piercing or markings that are inappropriate, present a safety hazard (i.e. in physical education or when participating in sports), or are disruptive to the educational process and/or specific trade setting;
- 3) Outdoor clothing (unless worn for a specific trade setting or medical reason);
- 4) Gang-related attire and/or jewelry;
- 5) Clothing and jewelry bearing inappropriate, lewd, profane, suggestive, drug, alcohol, tobacco, and/or any related messages;
- 6) Hats worn inside the school except for medical or religious purposes or for a specific purpose or trade setting; hats worn to school are to be stored in the student's locker and are not to be carried in the halls;
- 7) Straps must be lasagna in width, no tank tops for boys, or spaghetti straps for girls;
- 8) Clothes are to be worn as they are designed. (i.e. boy's pants worn on the waist, hooded sweat shirt over the body and both arms;
- 9) Headsets/ear buds/headphones/electronics (including when not on ears;
- 10) Back Packs (during the school day 8:15 a.m.—3:05 p.m.)

Students who violate the school's dress code shall be required to modify their appearance by replacing, covering and/or removing the offending item. Any student who refuses to do so shall be subject to corrective measures/discipline.

II. CORRECTIVE/DISCIPLINARY MEASURES

Corrective/disciplinary measures are used to deal directly with situations that arise on school property and at school functions.

The following range of corrective/disciplinary measures can be imposed individually or a combination of these may be used for violations of the Code of Conduct. The corrective/disciplinary measures include:

- · Verbal Warning
- · Written Warning
- · Time Out
- · Written Notification to Parents/Guardians
- Probation
- Detention (During lunch or after-school with parent notification)
- Suspension from social or extracurricular activities
- · In-School Suspension (ISS)
- · Out-of-School Suspension (OSS)
- · Alternative Education
- · Exclusion from Class
 - Expulsion, after Superintendent's Hearing

The above penalties may be imposed either alone or in combination.

IV. STUDENT SEARCHES AND INTERROGATIONS

To ensure the school learning environment is safe, federal and state laws authorize that school officials may conduct searches with "reasonable suspicion" on school property and at school functions. School administrators and school officials may conduct student searches. These searches may include the student, as well as the student's belongings (including cell phones). Students are not entitled to a "*Miranda*" – type warning before being questioned by school officials, nor are school officials required to contact a student's parents/guardians before questioning the student. However, they should explain to the student the reason for the search and questioning.

Students do not have exclusive use of their lockers, desks, computers and other school storage places. Students have no reasonable expectations of privacy with respect to these places, as school officials retain complete control over them. This means that students' lockers, desks, computers and other storage places may be subject to search at any time, without prior notice to students, without their consent, and without "reasonable cause".

If an illegal or dangerous item is found during a search, the Superintendent will maintain control and custody of it.

IMPORTANT LEGAL NOTIFICATIONS

PESTICIDES

LaFargeville Central School currently does not use pesticides. You can sign up to receive notification of pesticide use should we have the need to use them in the future by going to our "Parent & Community" tab on the district website www.lafargevillecsd.org and clicking on the document and resources link. Should you not have access to the internet and are interested in more information please contact the district office at (315) 658-2241 option 2.

ASBESTOS

LaFargeville Central School maintains an effective asbestos-management plan and asbestos inspections are conducted on a regular basis, as required by law. All inspections have determined LaFargeville Central School to be a safe working environment.

LIMITED ENGLISH PROFICIENCY (LEP)

Any parent/guardian of a student that has been identified as a participant in a Limited English Proficient (LEP) program has the right to an ESL program or to decline enrollment in the program.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

Parent/Guardians have the right to inspect and review education records, seek to amend education records, and consent to the disclosure of personally identifiable information from education records except as specified by law. In order to do so, a written request must be delivered to LaFargeville Central School and ample time given for the location of such records. These rights transfer to the student when he or she turns 18 years of age. Parents/Guardians also have the right to file a complaint with the Family Policy Compliance Office.

TITLE I LEA PLAN FOR HOMELESS STUDENTS

LaFargeville Central School (LCS) provides the same Title I service for all students including those who are homeless. LCS is a Title I school-wide school. Those students in shelters would temporarily reside in Watertown; LCS would purchase those services from Watertown City schools. All those who are located within the boundaries of LCS are enrolled upon arrival. Our efforts to identify homeless students include contacting Jefferson Lewis County Department of Social Services, Child Protective Services, the Probation Department, and advertising accessibility of LCS homeless students at various locations around the district. These locations would include stores, post office, campgrounds and state parks. The LCS enrollment form includes the living arrangement for unaccompanied youth.

Notification of Rights Under the Protection of Pupil Rights Amendment (PPRA)

Parents/Guardians have the right under PPRA to receive notice, give consent or choose to opt out, and/or inspect any surveys, collection and use of information for marketing purposes, and physical exams that concern any of the eight protected areas, which include: political affiliations or beliefs of the student or student's parent, or psychological problems of the student or student's family, sex behavior or attitudes, illegal, anti-social, self-incriminating, or demeaning behavior, critical appraisals of others with whom respondents have close family relationships, legally recognized privileged relationships, such as lawyers, doctors, or ministers, religious practices, affiliations, or beliefs of the student or parents, or income, other than as required by law to determine program eligibility. The LaFargeville Central School District will continue to implement policies in accordance with PPRA.

Every Student Succeeds Act (ESSA)

All teachers and teacher assistants at LCS, at the time of printing, meet the qualification requirements of NYS and ESSA.

- AM BOCES and PK are open.
- PK-5 busing will be 1 hour later as classes begin at 9 am
- 6-12 busing and classes will begin at 10:15 am as normal (buses may be a few minutes later)
- AM BOCES run will leave LCS at 9:20
- Buses to out of district placements will run 1 hour later

2) 2-Hour Delay

- AM BOCES and AM PK are cancelled
- K-5 buses will run 2-hours late and classes run from 10-3:00 pm
- 6-12 will go all virtual with classes at the scheduled times (10:15-3:01)
- PM BOCES run will leave at 11:50 am
- Buses to out of district placements will run 2 hours later

3) LCS Closed - SNOW DAY!!!

- The first 5 times we close:
 - Traditional Snow Day!!
 - School is cancelled and there will be no buses, classes, or activities for any LCS student.
 - BOCES and Out of District Classes No School!
- On our 6th closure and beyond (if needed)
 - Virtual learning day for students
 - All students will have ALL classes virtually at their regularly scheduled times and are expected to log in to each class as instructed by their teacher(s)
 - · All bus routes and activities are cancelled
 - BOCES and Out of District Classes No School!

4) BOCES/Other District is closed/delayed, but LaFargeville is open

- If the school your student attends outside the LaFargeville District is closed or delayed, then your classes at the other district are cancelled or delayed as directed.
- If you have classes at LaFargeville and we are still open, you are expected to attend your classes at LaFargeville

Note: If BOCES is closed, then student-athletes only need to be in attendance for his/her scheduled LCS classes to remain eligible to participate in athletics.

Test Taking Tips

Before the Test

Eat well and be well rested.

Studies show that you need good nutrition and sufficient sleep to concentrate and perform your best. Unopened water bottles are allowed in the test rooms.

Bring the right supplies.

Bring your pencils, erasers, pens, rulers, compasses, calculators, or whatever else you'll need on test day.

During the Test

Read the directions.

Never assume you know what the directions say,

Answer easy questions first.

Answering easier questions may jog your memory about useful facts. You may also come across Information that can help you with other questions.

Answer every question.

There's no penalty for wrong answers (except on SAT). It can't hurt to try.

Ask questions.

If a question isn't clear, talk to your teacher. If that's not possible, explain your answer in the margin.

Identify key words.

This will help you focus on the main idea of challenging questions.

Rephrase difficult questions.

To understand questions better, rewrite them in your own words, but be careful not to change the meaning.

Organize your thoughts before you write.

Spend some time organizing your responses to short-answer and essay questions. You'll reduce the time you need to revise.

Write neatly.

Be sure you don't lose points on answers the instructor can't read.

Use all of the time you're given.

If you finish early, don't race out. Use the extra time to proofread and edit your answers.
